PUBLICATION AUDIT FOR THE YEAR 2003

A self-analysis for the Year 2003 shows that we have made satisfactory progress. A total of one hundred six new manuscripts were received for publication from within the country and overseas, an increase of 25% as compared to the Year 2002 (Table-I). This

included seventy seven original articles. Most of the manuscripts received from within the country came from Karachi and Lahore as usual (Table-II). However ever since the start of online edition in 2001, the visibility and readership of the journal has increased tremendously with the result that the number of manuscripts received from overseas for publication has also increased by almost 100% as compared to the Year 2002. (Table-III)

There has been a steady increase in the number of original articles published during the Year 2000, 2001, 2002 and 2003 and over 100% increase in the number of interesting case reports published during the same period¹ (Table-IV). During 2003 while nineteen original articles were accommodated after primary

during the year also increased as compared to the previous years (Table-VI). To help achieve this objective, we have now acquired a separate new domain for the journal i.e. pjms.com.pk with more space keeping in view our future requirements. The Online edition now also contains the full text of all the manuscripts published in the journal in the PDF format as well. It will help the authors as well as readers to download the entire manuscript easily and have as many reprints as they wish.

The instructions to authors have also been updated keeping in line with the Uniform requirements for manuscripts submitted to Biomedical Journals: Writing and Editing for Biomedical Publications as approved by International Committee of Medical Journal Editors

revised in November 2003.² It has been made mandatory for the authors and reviewers to disclose conflict of interest if any, source of funding and the approval of the study by the Ethics Committee/International Review Boards of the respective medical institutions. The Referees and Reviewers will also have to disclose the conflict of interest if any. The authors will be required to carefully follow the criteria of authorship as per ICMJE guidelines.

In order to ensure quick review, all the new manuscripts being received for publication will get through the first internal review process within two weeks time. All those manuscripts, which are not selected for further review process, will be returned to the authors so that they can submit it somewhere else if they wish to without much waste of time. As decided earlier³ the publication of some special supplements on important subjects will be initiated

during the current year. A special Guest Editor for these supplements will be selected who will be overall responsible for the contents of that particular issue. However, all the manuscripts included in these supplements will go through the same review process to ensure that only quality manuscripts are accepted for publication.

EMBASE/Excerpta Medica of Netherlands besides the WHO Index Medicus IMEMR/ ExtraMed is already covering the journal. CAB Abstract and Global Health of UK have also started covering the Pakistan Journal of Medical Sciences since October 2003. Pakistan Journal of Medical Sciences has also been included in the Directory of Open Access Journals (DOAJ) http://www.doaj.org/ Our ultimate goal is to get it included in the Medline for which the National Library of Medicine at Bethesda USA and their Technical Selection Committee is being requested to re-consider the inclusion of PJMS and we are hopeful of a positive decision in the days to come.
